
#### **GOOD PRACTICES**

Science and business experience –project implemented under the Poland-Belarus-Ukraine 2007-2013 Programme including: seminars and conferences on trade and cross-border cooperation, study visits, guide for developing cross-border entrepreneurship and four-language portal - a cross-border database of entrepreneurs' cooperation.

Passport to Export – support for implementation of an export development plan under Innovative Economy Program 2007-2013, addressed to SMEs with a share of exports on the Single European Market and to countries outside this market, in total sales not exceeding 30% with export development plan drawn up not earlier than year before submission of the application.

Innovative Economy Operational Program 2007-2013 - programme focused on comprehensive support for R&D-related ventures which provided businesses undertaking them with a competitive advantage on the Single European Market as well as on international markets. Grants on scientific activity conducted to the benefit of businesses and providing economy with new generation technology solutions.
